**MECHANICAL CODE ORDINANCE**

AN ORDINANCE TO DESIGNATE AN ENFORCING AGENCY TO DISCHARGE THE RESPONSIBILITIES OF THE TOWNSHIP OF LAKE UNDER THE PROVISIONS OF THE STATE CONSTRUCTION CODE ACT (ACT 230, P.A. OF 1972).

THE TOWNSHIP OF LAKE ORDAINS:

**SECTION I**

THIS ORDINANCE SHALL BE KNOWN AND CITED AS "ORDINANCE NO. 29 - LAKE TOWNSHIP MECHANICAL ORDINANCE".

**SECTION II**

AGENCY DESIGNATED: PURSUANT TO THE PROVISIONS OF THE STATE OF MICHIGAN PLUMBING CODE AS SUPPLEMENTED, IN ACCORDANCE WITH ACT 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED, THE MECHANICAL OFFICIAL OF THE TOWNSHIP OF LAKE UNDER ACT 230 OF THE PUBLIC ACTS 1972 AS AMENDED, STATE OF MICHIGAN. THE TOWNSHIP OF LAKE HEREBY ASSUMES RESPONSIBILITY FOR THE ADMINISTRATION AND ENFORCEMENT OF SAID ACT THROUGHOUT ITS TOWNSHIP LIMIT.

**SECTION III**

ALL ORDINANCES INCONSISTENT WITH THE PROVISIONS OF THIS ORDINANCE ARE HEREBY REPEALED.

**SECTION IV**

THE ORDINANCE SHALL BE EFFECTIVE AFTER LEGAL PUBLICATION AND IN ACCORDANCE WITH THE PROVISION OF THE ACT GOVERNING THE SAME.

**SECTION V**

THE MECHANICAL INSPECTION AT THIS TIME SHALL BE MARK E. VICK - REGISTRATION NUMBER P001846.

**SECTION VI**

EFFECTION DATE - UPON APPROVAL OF THE STATE OF MICHIGAN CONSTRUCTION CODE COMMISSION.

THE FOREGOING ORDINANCE NO. 28<sup>9</sup> IS HEREBY DECLARED TO HAVE BEEN ADOPTED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF LAKE, ROSCOMMON COUNTY, MICHIGAN, AT THE REGULAR MEETING HELD ON THE 21<sup>ST</sup> DAY OF JUNE, 1994 AND ORDERED TO BE GIVEN PUBLICATION.
