Motion Hibbard seconded by Hassler R1 To allow six (six) foot privacy fence from front corner of dwelling to closest corner of detached garage, to road right of way, not to exceed setbacks. AIF (Grabowski-opposed, Surprenant-opposed) MC

Motion Hibbard seconded by Trier to accept Ordinance 55D with changes. Hibbard-yes, Hassler-yes, Trier-yes, Grabowski-no, Surprenant-no (3-yes,2-no) MC

Short Term Rentals – Discussion

Trier short term rentals are here to stay we have thirty to forty already. Everyone complains that we do not ticket or enforce. That is my not my task. We write tickets they pay then go on renting. We have been to court several times and cases get dismissed. Once attorneys get involved it costs thousands. If allowed, we can police them, and problems occurs we can address them to remove. We don't have a ordinance against them, either allow them and get a police power to regulate them or write an ordinance against them. Surprenant, in favor of STR's if they are in commercial districts only. Sees the need for them for police power and protection future litigation that may come from state legislation.
