
INTRODUCTION

Lake Township is located on the North Bay and West Shore of Houghton Lake. The bountiful resources of Houghton Lake and the Muskegon River which feeds out of Houghton Lake from the north bay provide exceptional resources for recreational activities. However, Lake Township currently does not have any recreational facilities nor provides public access to these resources.

Lake Township does have several state-owned facilities that offer access to Houghton Lake including the North Houghton Lake State Forest campground and boat launch and the West Houghton Lake boat launch. Also, the access to the Muskegon River and the Dead Stream Flooding on the westerly side of the Township is a state-owned facility. The Houghton Lake Flats is yet another state-owned area that has limited access for wildlife viewing, fishing, and hunting.

The Lake Township Board wants to provide recreation for its citizens and visitors. The goal is to create safe areas that serve the existing community and future generations and that will continue to make Houghton Lake and Lake Township a "destination place" for tourists and visitors.

The Lake Township Board is committed to implementing the recreation plan contained herein. The board will budget the needed dollars to supplement funds garnered from granting agencies and other sources to achieve this goal.



Extent of Focus

This Recreation Plan addresses recreational facilities and characteristics within the boundaries of Lake Township. The plan will evaluate the surrounding recreational opportunities as well as the socio-economic status of the Township and surrounding area to determine recreational needs of the population and to plan for improvements which fit those needs.

Location and Regional Setting

The Township of Lake is in the middle of Michigan's Lower Peninsula in Roscommon County. Lake Township is one of eleven townships located in Roscommon County. It is nestled between Lyon Township to the north Markey Township to the east, Roscommon Township to the south, and Enterprise Township of Missaukee County to the west. The township comprises approximately 35.6 square miles with approximately 23.8 square miles of land and 11.8 square miles of water (**Map 1-Regional Location**).

Lake Township is also a part of the greater Houghton Lake area which is comprised of four townships surrounding the lake. Lake Township is the smallest township on Houghton Lake and has several characteristics that define it as a rural resort and retirement community. Lake offers its residents a high quality of life.


Geography

As mentioned, a major body of water included within the Township boundaries is the nationally known Houghton Lake. North Bay, found in the township at the northwestern portion of the lake, provides access for the many residents and their guests to one of the more fabulous all-sports lakes in the state as well as the Midwest.


The Muskegon River originates from the North Bay of Houghton Lake and traverses across the northern part of the township where it converges with the Dead Stream. From there it flows southwesterly to the township line and creates the Dead Stream Flooding. The Dead Stream Swamp, with portions located in the north and west central parts of the township, is an exceptionally large example of a northern white cedar swamp, and one of the largest in the United States. Portions of this swamp are considered to be the climax in bog forest development.

The township is mostly forested which is utilized as woodlands and hunting lands (Map 2 – Land Cover). Minimal cleared land is used for agriculture purposes and residences. Au Sable State Forest is located throughout the township. Forested wetlands, scrubshrub wetlands and emergent wetlands are scattered throughout the township and are mostly associated with the drainage areas for the Muskegon River and Dead Stream. A portion of the Houghton Lake State Forest is in Lake Township. This forest provides

wildlife habitat, esthetic, and scenic values as well as the potential for lumber and heating fuel.

The abundant wildlife which relies on these varied habitats provides recreational opportunities not only for residents of the Township but also for many visitors to the area. Large and small game hunting, an activity enjoyed by many includes white tailed deer, black bear, rabbit, squirrels, and wild Turkey, among others. Bird watching and wildlife observation had become another preferred recreational activity not only in Michigan but also in most other parts of the country. Lake Township affords the participants great viewing opportunities in the area due to the variety of available habitats and accessible lands.

Lake Township has no municipal water supply therefore, residents and businesses use individual wells to supply water. Typical well yields of 10 to 100 GPM with a six" diameter well in bedrock or glacial deposits. Most of the entire township falls within the Muskegon River Watershed.

Land Use

The most predominate land use in Lake Township is State Forest. The State of Michigan owns about 10,800 acres throughout the Township. The Houghton Lake Flats area includes 770 of those acres. This wildlife management area is controlled and maintained by the Michigan Department of Natural Resources.

Lake Township is where the Muskegon River begins its journey west to Lake Michigan. About 5 miles of the river runs through the township and is used for fishing, kayaking, and canoeing. Another unique feature of the township is the many man-made canals that run through it.

Lake Township is divided into eleven zoning districts (**Map 3 – Zoning Map**). Of the districts governed by the zoning ordinance, the Forest and Recreational District comprises most of the township. Residential districts cover the developed area around Houghton Lake with commercial districts located along the M-55 and Old US-27 highway corridors. Multiple dwelling units are permitted in any district with approval of the planning commission.

Zoning Districts

- **AG (RA-3)** It is the purpose of the **AG Agricultural / Forested District** to preserve and encourage farming, dairying, forestry operations and other such rural type activities in areas where such activities exist. Large vacant areas, fallow land and wooded areas may also be included in this district.
- **R-1 Residential District** is designed to be the most restrictive of the residential districts to encourage an environment of predominantly low-density, single-family dwellings.
- **RR-1 Residential District** is designed to be the most restrictive of the rural residential districts to encourage an environment of predominantly low-density, single-family dwellings.
- **R-2 Residential District** is designed to permit a greater density of residential development than that provided in the R-1 Residential District classification.
- R-3 Residential District is designed to permit a greater density of residential development than that provided in the R-1, RR-1, and R-2 Residential District classifications.
- **R-4 Residential District Mobile Home Park** is designed to permit for the growing trend toward mobile homes and mobile home parks and the need for well-located and properly developed areas to accommodate them by use under appropriate construction and development standards to promote the health, safety, and general welfare of the residents of such areas as well as the residents of adjoining premises. The area zoned for such purposes should be able to accommodate the increased traffic generated from such developments as well as the necessary utilities.
- **C-W Commercial Waterfront District** is designed to allow commercial enterprises along the waterfront that support tourism and can co-exist with residential zones.
- **C-1 Commercial District** is designed to provide retail sales and commercial service uses catering to the public as distinguished from industry or general business customers, but do not become a nuisance or cause other objectionable disturbances or excessive noise.
- **C-2 Commercial District** is designed to permit commercial uses more extensive than the retail variety, occupying greater land areas for each such use, but does not cause a nuisance, objectionable disturbance, or excessive noise.
- **MO Marihuana Overlay District** is intended to provide opportunities for the development of certain Commercial Marihuana Facilities.
- **FR Forest and Recreational District** is composed of State-owned lands. It is so named for identification purposes only. For zoning purposes, it shall be zoned the same as the abutting privately owned property.



Climate

In Lake Township the summers are warm and partly cloudy, and the winters are freezing, snowy, and mostly cloudy. Over the course of the year, the temperature typically varies from 11°F to 80°F. Temperatures are rarely below -6°F or above 89°F.

The warm season lasts for 3.7 months, from May 24 to September 15, with an average daily high temperature above 69 °F. The hottest month of the year in Lake Township is July, with an average high of 80 °F and low of 57 °F. The cold season lasts for 3.4 months, from November 29 to March 11, with an average daily high temperature below 37 °F. The coldest month of the year in Lake Township is January, with an average low of 13 °F and high of 27 °F.

Lake Township receives some type of precipitation 147 days of the year. An average of 31 inches of rain and 60 inches of snow falls each year. The climate in Lake Township is conducive to both winter and summer recreational activities.

Demographics

The Lake Township population decreased by 8 percent from 2010 to 2020 from 1,215 to 1,119. This is the equivalent of 31.4 persons per square mile. Over this ten-year period, the county population has decreased 4.0 percent, the state has increased 2 percent and the United States population has increased 7.4 percent.

Lake Township residents, like most of the region, are almost all white (98.2%) and are equally divided between the sexes, (577 male, 594 female). Most Residents are homeowners (89.3%) where the average household size is 2.12 persons. The median age in the township is 61.5 years, with 43% of the population aged over 65 years of age.

The average commuting time for township residents is about 32 minutes as compared to 27 minutes for the average commute time for all U.S. residents. Lake Township residents travel to local cities such as West Branch, Houghton Lake, Prudenville, Roscommon, Gladwin and as far away as Gaylord and Cadillac for work and shopping.

Most of the recent growth in the county has occurred around Higgins and Houghton Lakes which have Michigan's highest concentration of vacation / seasonal and part-time dwellings. The summer population of the township is estimated to be at least double as 64% of the Lake Township's housing units are seasonal or recreational.

County Socioeconomic Characteristics

Roscommon County is rural and forested. It is about 60 - 90 minutes north of the industrial tri-city region of Midland, Bay City and Saginaw. The economic base of the county includes recreation, agriculture, manufacturing, and government employment.

The population of the county is, 23,459 peaking at 24,996 in 2013, leveling off and decreasing since then. The county has a work force of about 7,533 persons that typically commute over twenty-five miles to work. Unemployment in the county is high, 9.3% when compared to both state, 5.6% and national rates 4% (December 2021).

Ninety percent of Roscommon County's residents over 25 years of age have high school diplomas with approximately fifteen percent with bachelor's degrees. The median household income for 2019 in Lake Township was \$45,048, and in Roscommon County it was \$42,054. The State of Michigan median income was \$57,144 and \$62,843 for the United States.

17% of Roscommon County's residents work in the retail trade industry, 12% in accommodations and food service, 12% in health care and 10% in manufacturing. Large employers in Roscommon County include Lear Corporation, Wal-Mart, Home Depot and the many locally owned hotels, bars and restaurants that cater to the large influx of tourists.

Transportation

Lake Township is most often accessed by two major north-south State of Michigan Highway corridors. US-127 runs on the West side of Houghton Lake, through Lake Township and the I-75 corridor on the east side. M-55 is the major east-west corridor connecting the southern end of Lake Township to these two major highway corridors. M-55 is the commercial and mixed-use corridor on Houghton Lake providing the surrounding communities with its commercial, tourism, and recreation-based businesses.

Residents and visitors to Lake Township rely primarily on private vehicles for transportation. Public transportation is available through the Roscommon County Transportation Authority which allows for scheduled rides countywide, six days a week. Recreational vehicles such as snowmobiles and ORV's are operated on county and local roads and allow for easy access to trails.

Major transportation routes cross Roscommon County. Interstate I-75 transects the northeastern portion with US-127 splitting the county running north and south through the county. There are four truck companies that deal in the county. Greyhound Bus Lines and Indian Trails provide bus passenger service. The Lake State Railroad hauls freight in the county. Air travel and freight can go through the MBS International Airport in Saginaw, Bishop International in Flint, and Capital Region International in Lansing. The largest airlines serving these airports are Delta and United Airlines.


CHAPTER TWO ADMINISTRATIVE STRUCTURE

Township Administrative Structure

Lake Township is a general law township with a township board consisting of a Township supervisor, Township clerk, Township treasurer, and two Township trustees. These positions are chosen by registered voters of the Township in an at-large election held every four years. The Board oversees daily operations and budget expenditures. Maintenance and capital improvements are typically performed on a contractual basis, although there have been significant volunteer efforts in both areas.

This coordination of efforts will help to provide the best facilities and opportunities for recreation for all citizens and visitors to the area. Lake Township will endeavor to make its parks and recreation programs open and accessible to all its citizens. The township will maintain a policy of constructing its new facilities to meet barrier-free standards, and all repairs and improvements will be done to those specifications. All programs run by the township and those conducted by the county, school district or other agencies are designed to include the handicapped and structured so that all may afford them.

CHAPTER TWO ADMINISTRATIVE STRUCTURE

Role of Lake Township Board

The Lake Township Board will have absolute authority over all recreation functions in the township. The responsibility for financing operations and maintenance of all recreation improvements and activities will be that of the Lake Township Board and will be based upon the recommendations of Planning Commission and the Parks and Recreation Advisory Board.

Role of Planning Commission

The planning commission is a 5-member board that serves 3-year terms. The planning commission is responsible for completing and updating the 5-year Recreation Plan and Master Plan. The planning commission works closely with the Parks and Recreation Advisory Board. The planning commission will continue to keep the future growth of the township a top priority.

Role of Park and Recreation Advisory Board

The Park and Recreation Advisory Board was implemented in 2022 (**Appendix A – Establishment of Advisory Board**). The newly formed advisory board is made up of a cross section of interested residents and will help the township move forward on recreation projects, goals and needs. This board will be the voice of the community on recreational issues and report back to the Planning Commission and Township Board.

Role of Maintenance Contractors

Currently the township has no maintenance employees on the payroll. Much of the work done for the township is through the hiring of maintenance contractors. As plans develop in the township for recreation, this will be area that may need to be addressed.

Role of Volunteers

Volunteers will play a vital role in the development of Lake Townships recreation system. With limited amounts of money available, volunteers along with board members may provide needed work and maintenance at new facilities.

Budget for Recreation

The lake Township board has the authority to commit funds for Parks and Recreation, accept grants, and purchase land on behalf of the community. The township board has allocated \$200,000.00 towards the Muskegon River bridge project in 2022. The recreation capital improvement schedule is detailed in Chapter 6. Lake Township is a small community and will look for grant opportunities and local organizations for funding assistance.

Introduction

Recreational services from parks, natural areas, private businesses, Michigan Department of Natural Resources (MDNR), and public spaces are used by residents of Lake Township. Currently the township does not own or operate any recreational facilities. The following inventory was conducted by physical inspection, committee knowledge of the area and information from other communities' recreation plans.

Facilities locations are IDed on the maps located on page15 and 16.

CHAPTER FOUR DESCRIPTION OF PLANNING PROCESS

Basis for Action

Lake Township is blessed with an outstanding abundance and variety of natural resources but has no developed recreational facilities. Past recreation plans have yielded no results. The present township board has decided to pursue the creation of a realistic recreation master plan and to implement that plan over the next 5 years.

The Township has a large older population. The townships median age is 61 years old which is older than the state of Michigan median age of 39. Individuals 45 to 64 make up 31% of the population while individuals aged 65 and older make up 42% therefore this population should be given consideration when planning for recreational activities.

Another consideration in the planning process is the townships median household income. Lake Townships median income is \$45,048 compared to the State of Michigan average of \$57,144. Almost 58% receive social security compared to 22% statewide. Consideration will be given to whether residents can afford to incur the cost of any type of new taxes.

Although Lake Township has a small full-time population, the summer brings an influx of second homeowners and visitors. Houghton Lake (the lake itself) provides much recreation for residents and visitors with swimming, boating, and fishing to name a few. All residents and visitors should be able to enjoy recreational opportunities in their township. When planning, consideration will be given to the type of parks, their location and the type of recreational activities to be offered.

The needs and opportunities realized by the results of the survey and public input from meetings has been developed into the goals set forth in this plan.

Description of Early Public Input Process

The first step in acquiring public input was a recreation survey sent to all residential property owners in Lake Township. 1504 surveys were sent out at the beginning of November 2021. The survey included a letter explaining the reason for the survey, a stamped self-addressed return envelope and the survey itself.

The goal of sending the survey to all property owners was to elicit as much of a response as possible. As stated earlier, the township has many part time residents and snowbirds. The only way to reach many residents in the off season was by mailing a survey to their home. The commission also felt that the stamped envelope would increase response. **The township received 748 surveys back (50%).** Many of the surveys contained comments which were included in the decision process. Full survey results are in **Appendix B**.

CHAPTER FOUR DESCRIPTION OF PLANNING PROCESS

30 Day Review Period - April 7, 2022, to May 7, 2022

The thirty-day review period began on April 7, 2022, with the publication of notice in the Houghton Lake Resorter (March 31, 2022), email sent to township residents with email information on file, and a posting at the Lake Township Hall. The full draft plan was posted on the township website and available in hardcopy at the Lake Township Hall. The post included both the dates of the 30-day review and the date of the Public Hearing. No public comments were received during the 30-day review period.

Appendix C contains the Affidavit of Publication.

Public Hearing

The Public Hearing was held on May 17, 2022. Four members of the public were in attendance, but none had a comment on the recreation plan.

The meeting minutes are included in **Appendix C**.

Resolutions of Adoption

The Lake Township Planning Commission signed the Resolution of Adoption at the May 17, 2022, meeting. Resolution of Adoption is included in **Appendix D.** Meeting minutes are from the Public Hearing Meeting included in **Appendix C.**

The Lake Township Board adopted and signed the Resolution of Adoption at their meeting on July 12, 2022.

The minutes and resolution are included in **Appendix D.**

The goal of recreational planning in Lake Township is to promote and encourage the use and development of recreational facilities that meet the needs of the residents of the township. Providing low-cost recreational opportunities to our residents, both full and part time, tourists and visitors is a priority.

The following factors were used for analysis of the townships goals and objectives: survey results, public hearing input, Lake Township Board's goals and input, land, and budgetary constraints. Careful review of these findings led to the development of the following goals for our five-year recreation plan.

General Goals

- 1. Improve the quality of life for residents and attract visitors to Lake Township by maintaining, improving, and expanding recreation within the Township and surrounding areas.
- 2. Provide a balance of recreational amenities which are oriented to the aging population to increase the desirability of the community for retirees.
- 3. Provide recreational amenities which are oriented toward the younger population and families to increase the livability of the community, to attract young families to the area and retain older youth.
- 4. Protect, promote, and preserve the area.
- 5. Develop and maintain strong local government involvement in recreational and tourism planning projects.
- 6. Improve the overall local economy by enhancing the livability of the community.

Muskegon River Pedestrian Bridge

Goal: To provide a pedestrian bridge over the mouth of the Muskegon River where it originates in the North Bay of Houghton Lake.

Objective: To provide a nonmotorized connection between the residential neighborhood located to the east of the Muskegon River with the residential neighborhood located to the West.

- **1. Action:** Conduct a feasibility study for the design and construction of the bridge.
- **2. Action:** Work with Roscommon County Road Commission on the use of the existing road ends for the new bridge.
- **3. Action:** Research grant opportunities for the bridge.

Basis for Action: Currently, pedestrian and bicycle traffic utilize the busy Old US 27 Highway bridge over the Muskegon River to cross from one neighborhood to the

other. The speed limit on Old US 27 is 55 MPH. The road has 3-foot paved shoulders. The site for the new non-motorized bridge is on a residential road with a 35 MPH speed limit and less traffic than Old US 27.

Lake Township Park

Goal: Develop a township park for use by residents and visitors to the area.

Objective: Acquire property or use existing township property to build a park for residents and their families to gather and enjoy the amenities of a playground, courts, walking trails and open recreational space.

- **1. Action:** Buy property from the DNR on East Houghton Lake Dr that is currently under review.
- **2. Action:** If property unavailable develop plans for township hall property.
- **3. Action:** Work with a playground design company to layout the basic structure of the park.

Basis for Action: Lake Township currently has no recreational facilities for its residents. The survey conducted by the Lake Township Planning Commission during the development of this recreation plan showed an interest in the development of facilities for residents. Walking trails (84%) and a children's playground (72%) both showed an above average interest with residents of the township.

Fishing Pier

Goal: Develop a safe and child friendly public fishing pier at the County Dam or at the Muskegon River Pedestrian Bridge.

Objective: If the Muskegon River Bridge project becomes a reality, then a fishing pier would be established at that site. There are two other possibilities for the establishment of a fishing pier. One being at the County Dam on the Muskegon River which is in Lake Township and option two being at the road end (were the bridge would start) if the bridge project fails.

- **1. Action:** Work with the County on the feasibility of a fishing pier at the County Dam. Possible County money for project.
- 2. Action: Work with the Roscommon County Road Commission on developing a safe fishing area at the north end of West Shore Dr. if the Muskegon River bridge project does not develop.

3. Action: If Muskegon River bridge project moves ahead, make sure that fishing pier is included in the plans as an addition at a later date.

Basis for Action: Lake Township is blessed with approximately 16 miles of shoreline on Houghton Lake and the Muskegon River. Most of this property is privately owned and therefore does not allow everyone access to fishing. Developing a fishing pier for residents who do not live on the lake or river nor have access to a boat would allow for many residents and visitors to enjoy fishing Houghton Lake and the Muskegon River.

Kayak/Canoe Launch

Goal: Develop multiple safe, ADA, and user-friendly public launch areas for kayaks and canoes to enjoy Houghton Lake and the Muskegon River waterways. Work with surrounding townships on the completion of the Blue Water Trail.

Objective: Work with the DNR and the Roscommon County Road Commission on areas to develop multiple kayak launch points to provide easy access to Houghton Lake and the Muskegon River.

- **1. Action:** Work with kayak launching system companies on the best type of ramp, dock and launch for our lake.
- **2. Action:** Contact the DNR to see if having a kayak launch at the DNR west Houghton Lake boat launch is feasible. Look at existing areas and boat traffic at the site.
- **3. Action:** Work with the County Road Commission on using the property at the West Shore Dr. Road end for a kayak launch in conjunction with the fishing pier.
- **4. Action:** Work with surrounding communities on the completion of the Blue Water Trail.

Basis for Action: The need for access to the water for residents who do not live on the waterfront and visitors is an issue for the community. Having kayak launches on public property would allow many the chance to enjoy the beauty of Houghton Lake.

Walking Trails

Goal: Develop rustic walking trails at the Lake Township Hall property.

Objective: Using the current 6 acres at the township hall property, develop walking trails and then work with the DNR to add additional trails on the adjacent State property to increase the length of the trails.

- **1. Action:** Work with a group of volunteers to walk and mark proposed trail, keeping distance, slopes, and future expansion in mind.
- 2. Action: Clear land and develop a system of directional markers for trail.
- **3. Action:** Work with DNR to expand trails onto the adjacent State property.

Basis for Action: The 6 acres at the Lake Township Hall property would provide for walking trails which was the number one priority for residents according to the recreation survey. With the land already owned by the township, the development of the trails could begin in the short term. The addition of State land in the longer term would make the hiking trails a great addition to the greater Houghton Lake area.

Ensure a through Recreational Planning Process

Goal: Create recreational opportunities for people of all ages and abilities within our township and the surrounding area.

- **1. Action:** Regularly update the 5-year Parks and Recreation Plan to ensure the recreation system reflects the current needs of the community.
- 2. Action: Seek grant funding and other financial assistance to help acquire and develop recreational facilities and the recreation goals of this plan.
- **3. Action:** Improve the quality of life for Lake Township residents and bring visitors to Lake Township and the surrounding areas by working with local and State governmental agencies, community service agencies and local businesses.
- **4. Action:** The Advisory Board will publish an annual report detailing the townships progress on the recreation goals contained in the 5-year plan.

Basis for Action: The need for recreational facilities in Lake Township has been ongoing for many years. The commitment of the current board to recreation for our residents is laid out in this plan.

CHAPTER SIX ACTION PROGRAM

This Action Program was developed by the Lake Township Board, Planning Commission and the Park and Recreation Advisory Board. The Action Program is based on public input received from the recreation survey, public input at meetings and current township financial conditions. This Action Plan was developed to carry out the goals and objectives set forth in the previous chapter. These projects are subject to the availability of funding through the township and grant acquisition.

APPENDIX A ESTABLISHMENT OF ADVISORY BOARD

Park and Recreation Advisory Board Rules of Establishment Lake Township Roscommon County Michigan

Establishment; Composition; Terms.

There is hereby established in the Township of Lake in the County of Roscommon a Park and Recreation Advisory Board consisting of seven (five) members all of whom shall be residents of the Township. Permanent members of such seven (five)-member board shall be as follows: one shall be from the Lake Township Board; one shall be from the Lake Township Planning Commission and the remaining five (three) members of the board shall be citizen members appointed by the Lake Township Board. One of such members will be appointed by the board to a three-year term beginning in April 2022, two (one) members shall be appointed to a two-year term beginning in April 2022, and two (one) members shall be appointed to a one-year term beginning in April 2022. All subsequent appointments to such board shall be for a three-year term. A five-member board will be established if not enough residents apply.

Purpose.

The Park and Recreation Advisory Board shall consider and study the reasonable needs of the Township Park and Recreation Program; serve in an advisory capacity when so required; function as a recommending body to the Lake Township Board on matters of general recreation policy; and formulate and report its findings from time to time to the Lake Township Board.

Election of Chairperson; Bylaws.

The Park and Recreation Advisory Board shall elect its own Chairperson and shall establish bylaws for the conduct of its business.
